

SUBJECT: Federal Wage System Regular and Special Production Facilitating Wage Rate Schedules for the

Rates are established as required by 5 USC 5343(d), if applicable, and are to be applied in accordance with the provisions of 5 CFR Part 532 to all employees whose official duty station is located within the geographic boundary of the wage area definition shown on the reverse side.
