  - (d) Office of Personnel Management letter, dated October 20, 2022, authorized the use of 5 CFR § 532.801 (unrestricted rates) in wage areas affected by pay inversion.
  - (e) Defense Civilian Personnel Advisory Service, Federal Wage System Regular and Special Production Facilitating Wage Rate Schedule for the 240R Columbus, Georgia (ATL) Wage Area, dated January 4, 2023.
