MEMORANDUM FOR COMMANDING OFFICERS OF MILITARY DEPARTMENTS AND
DOD COMPONENT INSTALLATIONS IN THE HONOLULU,
HAWAII WAGE AREA

SUBJECT: Nonappropriated Fund (NAF) Schedule of Special Rates – Fort DeRussy, the Department of the Air Force, Bellows Air Force Station and Navy Exchange Service Command, Joint Base Pearl Harbor-Hickam, Honolulu, Hawaii [Wage Area #106]

This letter amends the regular Crafts and Trades Wage Schedule #035 for the Honolulu, Hawaii wage area in accordance with the Office of Personnel Management (OPM) letters dated May 23, 2016, October 22, 2018, December 22, 2020 and October 13, 2022, which authorizes a schedule of special rates for certain occupations at the Hale Koa Hotel, Fort DeRussy, the Department of the Air Force, Bellows Air Force Station (AFS) and extends partial coverage to the Navy Exchange at Joint Base Pearl Harbor-Hickam (JBPHH). Please note that the specific occupational coverage for each component is shown on the reverse side of the schedule.

This special rates amendment expires with the implementation of the next survey-based regular schedule. In order to continue the authorization for special rates, the affected components are required to comply with the provisions of S12-6b of the Operating Manual, Federal Wage System, Nonappropriated Fund.
